Dear Mr. Venrick,

I have <u>a very urgent request</u> to make of you today. Perhaps the most important that I have ever made of you -- <u>and here's why</u>.

We here at the United States Justice Foundation (USJF) are pleased to be celebrating <u>our 35th year</u> of defending liberty and protecting the Constitutional principles on which our great nation was founded. But, <u>we are also now deeply involved in the most vitally important legal and grassroots efforts in our history</u>... and I need your support now, more than ever before!

Please, let me explain. <u>This is urgent</u>, and time is short. As I rush you this time-sensitive appeal, we are already working on several major 2014 cases and campaigns that will be front and center throughout the rest of this critical year.

Most important will be our efforts to ensure that justice is done with regard to what I believe is the greatest hoax ever inflicted on the American people. The hoax that I am referring to, of course, is Barack Obama's successful effort to place his name on both the 2008 and 2012 Presidential ballots, WITHOUT ever proving that he was a natural born U.S. citizen and, thus, eligible to serve as President of the United States.

 Are they preparing to declare Martial Law? Will Obama leave office voluntarily? Ever?

Most important of all is our campaign to <u>investigate the actions of</u>

Questions that include:

televised federal appellate court hearing on the issue of his eligibility. Experts have argued that the typewriter used to fill out this form did not exist at the time of Barack Obama's birth.

Plus, Mr. Obama's birth certificate was filled out differently than others done at the same time, in the same hospital. And, there is evidence that the form was prepared using a computer not in existence in 1961. We are determined to find out the truth about these issues with a team of independent forensic experts.

- 2) The Constitutional issue of Mr. Obama's, and Eric Holder's,
 Department of Justice argument saying that ordinary citizens
 -- meaning you and me -- do not have "standing" to challenge the eligibility of a candidate for President.
- 3) <u>The Constitutional issue</u> of ensuring, through the states, that eligibility is confirmed before a candidate is allowed on the Presidential ballot -- this was our *Keyes v. Bowen* litigation that we appealed to the United States Supreme Court.
- 4) The issue of whether Mr. Obama was adopted by his Indonesian stepfather, Mr. Sotero, and, as a result, lost whatever U.S. citizenship that he may have had.
- 5) The issue of Mr. Obama traveling to Pakistan in the 1980's, using a non-U.S. passport he has stated that he did not obtain a U.S. passport until he was a U.S. Senator (2004 or later).
- 6) Why does it appear that Mr. Obama has no valid Social Security number?
- 7) Why does it appear that Barack Obama never properly registered (as then required by law) for the Selective Service?
- 8) And, <u>did Barack Obama use Indonesian citizenship papers</u> to get into his first college, Occidental, in California?

These FACTS must be pursued by the Congress as early as possible here in 2014 -- and, with your help, we intend to do $\underline{\it EVERYTHING}$ in our power to ensure that they are.
