## REPORT FROM THE FRONT LINES

Dear Friend of American Policy Center:

Incredible is the only word I have for it.

When I started the American Policy Center (APC) I dreamed of a day when Americans would finally start to fight back to restore American Freedoms.

And I hoped APC would be a valuable tool in that effort.

But never did I envision the fact that the American Policy Center would actually be leading that fight.

The fact is, 2013 is a year I thought might never happen – the year when the U.N.'s Agenda 21 finally became a mainstream issue – discussed, debated and opposed in community meetings across the nation.

The Obama Administration and the United Nations are working hand in glove to enforce the U.N plan to take control of AMERICA's cities through Agenda 21.

This UN scheme is just another way to destroy American sovereignty and control our lives. It is a violation of our U.S. Constitution. It destroys American's system of limited government.

And right now, a United Nations-linked organization has already infested over 600 American cities with this subversive attack to lock away private land and force redistribution of personal wealth.

After hiding under the radar for more than 20 years, the U.N.'s Agenda 21 has become the cause of 2013 as thousands of concerned Americans began to study United Nations documents side – by – side with their local comprehensive development plans. To the horror of most, they found identical language – and the battle was on.

The battle to stop Agenda 21 in local communities and in state legislatures has taken several varied but effective paths.

In my travels to speak to more than 47 groups in 25 states last year, I have been privilege to meet and work with some of the most amazing activists I've ever encountered.

I've also been able to meet with state legislators in four states, along with a large number of county commissioners and city councilmen - all eager to learn about Agenda 21 and how to stop it.

Here are some of the results of APC's work in countering the massive power of those enforcing the U.N.'s Agenda 21 across the nation:

- **Communities Leaving ICLEI**

The United Nations-authorized group that calls itself the "International Council for Local Environmental Initiatives (ICLEI) helped write Agenda 21 back in 1992. Then they made it their mission to enforce it in every community in the nation.

The battle to expose and defeat ICLEI started January, 2011 in Carroll County, Maryland, as the newly elected Board of Commissioners, led by Richard Rothschild, voted to cancel the county's ICLEI membership.

Commissioner Rothschild learned about ICLEI and Agenda 21 from APC materials. One of his first calls after taking office was to me.

Following Carroll County, next came Amador County, California, as the county commissioners voted to end their membership in ICLEI; then came Montgomery County, PA; followed by Edmond, Oklahoma and Las Cruces, New Mexico.

The successful battle against ICLEI in Spartanburg, South Carolina was sparked by County Commissioner Roger Nutt. Again, he was using APC materials to help educate his fellow Commissioners.

Virginia became a hotbed of activity against the U.N.'s Agenda 21 and ICLEI, especially through the efforts of activists like Donna Holt, Cathy Turner and Charles Battig, to name a few. As a result of their efforts, Albemarle County, Virginia (home of Thomas Jefferson), James City County, Virginia (where America basically started at James Town), Abington, Virginia and Lexington, Virginia, have all voted to throw ICLEI out.

Donna Holt learned of the U.N.'s Agenda 21 threat after when she attended APC's Freedom Action Conference.

We can now add to this list Plantation, Florida; Carver, Massachusetts; Pinellas, Florida; Garland, Texas; Sarasota, Florida; Clallam County, Washington; Monmouth County, New Jersey, Chatham County, North Carolina and Somerset County, New Jersey and more.

Unofficial reports indicate that at least 150 communities have withdrawn from ICLEI. In addition, while ICLEI set a goal of 1000 American cities as members by 2015, indications are that thanks to our efforts, the United Nations is LOSING MORE CITIES THAN THEY ARE GAINING!

- **State Legislative Activity Against U.N.'s Agenda 21**

It has truly been amazing to see anti-Agenda 21 efforts in state legislatures across the nation. My report here is only a fraction of the activities actually taking place, as I literally can't keep up with the many meetings, hearings and resulting legislation that is being introduced. But here are a few highlights:

The Alabama legislature was the first in the nation to pass and have the governor sign a landmark anti-U.N. Agenda 21 law.

In the state of Washington, State Representative Matt Shea is succeeding in creating an "Anti-Agenda 21 Caucus," designed to educate fellow legislators to the dangers of the U.N.'s Agenda 21 and to block passage or any such legislation. Eight House Members have joined so far.

A bill will be introduced by Representative Mary Williams into the state legislature of Wisconsin to repeal state mandated smart growth legislation. Smart growth legislation has been passed in almost every state and is the Sustainablist's main weapon to enforce Agenda 21 policy in every county.

Similar legislation has already been passed and signed by the Governor in the state of Florida. That means that Florida counties are now free from state mandates to write and impose comprehensive development plans.

The state of New Hampshire has had two landmark bills before it. First is HB 1634, introduced by Rep. Amy Cartwright which prohibits "the state counties or towns from implementing programs of, expending money for, receiving funds from, or contracting with the International Council for Local Environmental Initiatives (ICLEI)."

The second bill in New Hampshire prohibits federal, state and local government agents from entering private property without the property owner's written permission. I have talked with several state legislators in New Hampshire about these bills, including sponsor Amy Cartwright.

And I am working with several legislators around the country to create language for effective legislation, using iron-clad definitions of true property rights, to fully stop the U.N.'s Agenda 21.

### **Republican National Committee Passes Anti-Agenda 21 Resolution**

On Friday, January 13, 2012, Helen Van Etten, Republican National Committeewoman from Kansas, sponsored a resolution entitled "Resolution Exposing United Nations Agenda 21." It was adopted during the RNC's general session that day. This resolution may now be used by all opponents of Agenda 21 to help convince lawmakers that this is a threat serious enough that one of the two major political parties now understands and opposes it.

Much of the RNC resolution uses information from my writings.

So, there you have it. A brief rundown of the growing battle to stop the U.N.'s Agenda 21. It has been an amazing year in this fight to resort the Republic.

But I believe that 2013 is already shaping up to be the year we finally crush the U.N.'s Agenda 21.

With the momentum we have now – we can do it!

The American Policy Center was one of the original organizations to fight Agenda 21 and Sustainable Development. But because I stuck to my guns and refused to back away from this fight, as a result of APC's efforts – now there are hundreds of organizations and leaders in every corner of the nation taking on this fight.

I intend to lead this fight – all the way to victory. And I need your help to do it.

Many of you have supported APC through these dark days when few were listening to my warnings about the U.N.'s Agenda 21.

You understood how vital this battle is. And you have been there to help provide us the funds we've needed to carry out the battle.

We are now seeing incredible impact from those efforts. I've never experienced anything so exciting or more rewarding.

The grassroots have clearly heard APC's warnings and they are taking up the fight – and are beginning to win on the local level – the battle against Sustainable Development.

The bottom line is this: The American Policy Center is having tremendous

influence. This "On The Front Lines Report" shows only a portion of our marathon of activities this past year.

And it is clear, based on the phone calls and letters I am now receiving that 2013 will be my busiest ever.

Already I have calls to speak -- or help organize efforts in several more states. Obviously I'm going to be on the road more than ever -- speaking, creating fire storms on local communities -- helping and training local activists to join the fight.

I'm writing to you today with a very specific and important plea. Let me say it as straightforward as I can:

**I need funds to continue to lead this fight.**

It costs APC a minimum of \$50,000 per month to cover overhead, mail costs, publishing the DeWeese Report, issuing action alerts, producing CDs and DVDs, travel, and all the things necessary to assure we are ready to handle the next crisis.

My small, dedicated staff produces an incredible amount of vital information each month - which is then used by thousands of Americans.

I would challenge any organization twice our size to match APC's output -- especially on our very small operating budget.

APC receives no grants from large foundations or corporations. Most organizations of our size depend on such grants for a major portion of their annual budgets.

I have chosen not to seek such funds because they usually come with strings attached. Large contributors rightly want to direct how their money is being spent. But I choose to remain as independent as possible because that keeps APC free to fight any battle we believe is important for American freedom, no matter who is on the other side.

And as a matter of fact, had I been taking corporate funding over the last several years -- APC would not have been able to fight Sustainable Development and the U.N.'s Agenda 21 because the large corporations are the major force behind it- and they would have stopped us!

So, I prefer to remain independent, but that means I must depend on individual contributions from loyal supporters like you.

I must tell you, 2012 had been one of the most difficult years for donations

So, I'm asking you straight out -- will you send APC a contribution today to assure we have the necessary funds to stay on the front lines?


