Greetings Interested Parties,

#### **SMP Approval!**

Last week you should have received notification from Jeffree Stewart, WA Dept of Ecology, that our ***Shoreline Master Program has been approved***, pending some required changes. The County received a letter indicating the SMP approval from Ecology's Director, along with three attachments that outline their findings and conclusions, required changes, and recommended changes. These materials are posted online at the [state website](#) as well as on our [County SMP website](#). *[Today there were some web glitches; should be fixed by the time you get this; if not please be patient as we work to correct any problems]*

#### **Ecology Documents**

Please note, that as we have begun reviewing these materials, we have found several "inadvertencies" in the form of erroneous page number references, code citations, and typos. For example, Ecology refers to 'Ordinance Number 77-09' when it should be 'Resolution Number 77-09'. As staff works with the Board of County Commissioners we will provide materials to identify and clarify those errors in order to aid County and public review of Ecology's decision and to support preparation of the County's response. These will be made available to the public.

#### **Press Coverage**

Both local newspapers – the *Leader* and the *Peninsula Daily News* – have published pieces on the SMP approval. Below are some points of clarification to assist the reader:

- The Board of County Commissioners will begin review of Ecology's approval on Monday Feb. 7 but will not take action for final adoption by ordinance on that date.
- While Ecology's findings and conclusions address the standard shoreline buffers and flexible options to adjust buffers on a case-by-case basis, buffers are not on the list of required changes.
- Ecology has not identified March 2 as a due date for County response. The 30-day time limit started on January 27, per RCW 1.12.040.
- The County's first SMP was established in 1974, with the last update in 1989 and the last minor revisions in 1998.

Ecology also distributed a press release to regional and local newspapers that is posted online at the State and County websites (links provided above).

#### **Next Steps**

Next steps in the final adoption process include:

- Review of required changes;
- Any 'counter offer' revision proposals for required changes as determined by the Board;
- Reply to Ecology that the County accepts their changes (or as revised);
- Staff preparation of an ordinance package; and
- Board final adoption by ordinance.

*THEN* the new SMP will be in effect upon the Board's final adoption.

As always, we will keep this email group informed.
