Smith filed his affidavit through California attorney Orly Taitz, v several lawsuits challenging Barack Obama's constitutional eligil president, as part of a case that includes as plaintiff former presidence.

Taitz posted on her blog Smith's declaration, which claims he obcertificate from Coast General Hospital in Mombasa, Kenya, and

Taitz hopes the court will order expedited discovery, a ruling tha Obama's currently sealed documents, including his college record form birth certificate, to court scrutiny.

WND also launched an investigation into "colmado_naranja," what several online aliases and reported collaborators, including Dawr "InspectorSmith" and, eventually, Lucas Smith.


Smith, whose background includes a lengthy criminal record and sell his kidney to a man in need of organ transplant, nonetheless are above board, even if his past looks dubious.

"I do have a background. I've made mistakes in my life," Smith to "It took a guy like me to go and get tangible proof about Obama. a few laws or policies here and there. I don't mind paying the mil countries to look the other way ... The military [in Africa] will granything for just a few dollars. People are starving. So yes, it take things done once in a while."


