

A Statistics Lesson to save the Republic and oh by the way, 71 million plus VOTED against Corruption!

I recently crunched all the percentage results reported for each state. To summarize, for ALL of the Republican Win States, on average, they voted 59.89% Trump and 38.50% Biden... no surprise, however how did Democrat States Vote? 57.88% Biden to 40.65% Trump, the margin was in the 2% range different than the votes in Republican States. Sure, Trump lost right?... but by tiny percentages in five states.

This anomaly seemed strange, so I calculated the Standard deviations of Republican State Votes (combining Trump and Biden Data) vs combined candidate Democrat State Votes, what this calculation would show is the variability IN VOTING of Republican States vs Democrat States. In theory **the variability, that is the randomness or scatter of the data should be the same**, that is not to say the results for **their candidate** have to be PROPORTIONAL. **Voting patterns are consistent across parties. The data SPREAD should be as tight for each side of EITHER Republican or Democrat voting blocks. The process of voting, not the vote count, would and should, be the same overall.**

Those variability Standard Deviation numbers range from 5.4 to 5.7 Sd for Republican States vs 9.07-9.1 Sd for Democrat States. Now while those difference may not mean anything to the average person, what that means to statisticians is that there is about 1.5+ TIMES as much variability in Democratic States Voting as there is in Republican States Voting and that is HUGE! What it means is the likelihood of that happening by chance is 86.22% against that occurrence, or simply put, one set of books is not matching the other. In voting terms, consider that **Trump "lost" to Biden 5.3% to 93.2% in DC!** In no other state, not even Wyoming was there such a PROPORTIONAL disparity and in Wyoming, Trump won 76.4 to 26.7%, **a nice win, but not in the same league as DC, the home of the swamp.** As I have said many times, when any voting ANYWHERE goes into the 90+% range, something is cooked. Funny, you haven't heard that percentage in the media, have you? Look it up yourself.

We can't see things like patterns hidden within data, without mathematics. When 140 million votes are cast there is no way to see such a pattern, but statistical analysis can show the hidden patterns.

Now to simplify, on average, the balance of win votes OVERALL was ABOUT 60/40 if it was a Republican STATE, Plus, the inverse, if it was Democrat STATE, (40% loss for Trump in those states), BUT wait, ...how come Wisconsin, Michigan, Georgia, Arizona and Pennsylvania ALL ran more or less 49% to 49%????????? Are voters in those states unique? Are they the opposite of ALL the other states in voting PATTERNS? I don't think SO. **If we also consider that ALL of those states used Dominion Corporation machines AND produced results counter to ALL the other State's Patterns, it SCREAMS FRAUD.
