Dear Fellow American Citizen,

Let me get right to the point.

I have no choice but to ask you and the other patriots that I am writing to today for a <u>special</u>, <u>emergency gift</u> of \$25, \$50, \$100, or more to United States Justice Foundation (USJF).

Please understand, under normal circumstances I would not be asking someone that I don't know personally for such a special favor.

But these are not normal circumstances -- and here's why!

As I rush you this urgent, time-sensitive appeal, we here at USJF are working on several major cases and campaigns that will remain front and center through the elections and the end of this most critical year in American history.

Most important will be our efforts to ensure that justice is done with regard to what I believe is $\underline{\it THE~GREATEST~HOAX~EVER}$ inflicted upon the American people.

The hoax that I am referring to is, of course, Barack Obama's successful effort to place his name on both the 2008 and the 2012 presidential ballots $\underline{\textit{WITHOUT}}$ ever proving that he was a natural born U.S. citizen, and therefore eligible to serve as a U.S. President.

My name is Michael Connelly. I am its lead attorney and its Executive Director.

For over 37 years now, we have been "the legal arm" of the conservative movement in America.

We battle the Left, both in the <u>court of law AND in the court of public opinion</u> each and every day -- and we win.

And, make no mistake: Exposing the truth (finally) about Barack Hussein Obama, while our first priority, is not our only important project.

In addition to our efforts to remove and prosecute Barack Obama, USJF has also taken a lead role in efforts to:

- ++ <u>Prevent Barack Obama</u> from placing ANY new Justice on the Supreme-

- ++ Accelerate our efforts to determine the truth about the IRS, NSA, Benghazi, and "Fast and Furious" scandals.

This is just a short list of the many projects and legal cases that we have on the table, RIGHT NOW, in 2016...

... and <u>it is absolutely vital that we avoid any funding shortfall,</u>
and that we build up a sufficient cash reserve to stay operating at 100%, and for the rest of the year!

Which is why I've gone to the extraordinary step of reaching out to Americans like you, who are known to care about our liberty...

... and why I hope that you will speed back a most generous donation of \$25 or more to USJF.

Again, I know that I am asking a lot of you today.

But again, we have a lot on our plate.

I am <u>most concerned</u>, of course, that justice is done in the case of Barack Obama's apparent criminal cover-up of his past.

Because there remain <u>many unanswered questions</u> about Mr. Obama's past, ones that go right to the heart of the question of whether he was ever eligible to run for, or serve as, President.

Questions that include:

- 1) The authenticity of the long-form birth certificate that Mr. Obama released in 2011. Experts have argued that the typewriter used to fill out this form did not exist at the time of Barack Obama's birth. Plus, Mr. Obama's birth certificate was filled out differently than others done at the same time in the same hospital. And, there is evidence that the form was prepared using a computer not in existence in 1961. We are determined to find out the truth about these issues with a team of independent forensic experts.
- 2) The Constitutional issue of Mr. Obama's Department of Justice argument saying that ordinary citizens -- meaning you and I -- do not have "standing" to challenge the eligibility of a candidate for President.
- 3) The Constitutional issue of ensuring, through the states, that eligibility is confirmed before a candidate is allowed on the Presidential ballot -- this was our Keyes v. Bowen litigation that we appealed to the United States Supreme Court.
- 4) The issue of whether Mr. Obama was adopted by his Indonesian stepfather, Mr. Sotero, and, as a result, lost whatever U.S. citizenship that he may have had.
- 5) The issue of Mr. Obama traveling to Pakistan in the 1980s using a non-U.S. passport -- he has stated that he did not obtain a U.S. passport until he was a U.S. Senator (2004, or later).
- 6) Why does it appear that Mr. Obama has no valid Social Security number?
- 7) Why does it appear that Barack Obama never properly registered

(as then required by law) for the Selective Service?

8) And, <u>did Barack Obama use Indonesian citizenship papers</u> to get into his first college, Occidental, in California?

These $\underline{\mathit{FACTS}}$ must be pursued by the Republican-led Congress $\underline{\mathit{TODAY}}$, and with your help and your support, we intend to do $\underline{\mathit{EVERYTHING}}$ in our power to ensure that they are.
