The property owners won't have the ability to fight it.

The government will throw some dollars at the property owners (well under its value) and say they have paid for the land.

The CLEAR Act will destroy local economies, severely damage small business, cost thousands of jobs, force rural families into the cities and generally destroy rural America.

The CLEAR Act has already passed the House and is now included in Harry Reid's energy bill in the Senate. We must stop it.

The second program Obama is trying to force through is called the **Great Outdoors Conservation Initiative**.

It goes hand in hand with the CLEAR Act.

Obama's Great Outdoors Conservation Act will establish a series of Wildlife Corridors covering several states and connecting existing national parks and other government areas.

It will expand existing wilderness areas and create new ones.

Many new national monuments will be established, locking away natural resources.

New National Heritage Areas. New National Parks. New National Trails. National Historic Areas. New Greenways. New National Preserves. New National Seashores. New View sheds.

Something called "sound sheds."

And now "air sheds" – meaning air controls on industry.

And it goes on and on.
