



Perhaps the State of Pennsylvania has given us an opportunity?.

Perhaps this abusive behavior by the state could rally a legal test suit challenging the applicable issue(s), e.g. illegitimate property taxes, income taxes and even till applied sales taxes. Now we have state sponsored abusive ads on illegitimate abusive taxes.

I am waiting for the Lone Legal Ranger or some enterprising freedom law firm to grab this opportunity. At least three states are ripe for a legal challenge. There are at least 3 state high courts who have already ruled property taxes, as currently applied, are unconstitutional and also one state board ruled the same.

Ex Special IRS agent (gun and badge carrying) Joe Banister, CPA has exposed the federal tax fraud that there is no law requiring a federal income tax either, it is voluntary for the natural born. Out of 100,000 IRS employees only 3 blew the whistle, one has disappeared, one is in prison dying and one convinced the jury the federal tax was voluntary for the natural born. 3 out of 100,000 is .003%. This is the leverage of fear.

The Matrix is self-perpetuating and self-protecting.

There are a number of tax freedom groups fighting various fraudulent tax takings in each state. Some like NTU are not on target to the complete elimination of the system. Some of the tax freedom groups and property rights groups want taxes if you can believe it. Everyone has their own brand of tax promotion that is better than the other. After 5 years of looking, I find no high founding or fundamental laws allowing the taxing of the natural born sovereign and free state Citizens. Nor it there any need for such tax masochism. This is why we revolted and why we documented all those abuses in the Declaration of Independence. It wasn't just about tea tax it was about all taxes.

The municipal corporate networks are corrupt and rich, i.e. filthy rich. No direct taxes or indirect taxes upon the natural born state Citizen's is necessary. Walter Burien makes this case. The government at all levels are presenting themselves as bankrupt and they are, in the sense they are over spending their massive annual revenues while at the same time taking on huge debt. State of Washington rough June 2009 gross revenue is some \$62 billion. This is more than The Boeing Company's 2009 revenue of \$60.9 billion. The Boeing Company is the largest aerospace and defense corporation in the world. At the same time the State of Washington chased away the Goose that was laying the golden egg but their revenue grows none the less. The municipal corporations are stashing billions away for themselves. The municipal corporate hierarchy model has been extremely successful because it

combines illegitimate tax taking with illegitimate enterprising in monopoly business, e.g. gambling and liquor. Does the word "mob" pop into your mind.

If you still cannot wrap your mind around this, the state's also have the ability to print and coin their own value based money with a 3/4 vote. You have to ask the rhetorical leading question, why haven't the states done this long ago and given up this debased feudal barbaric taxing system. You add the illegitimate and tyrannical taxes and regulations, usurious interest and lack of allodial title and you are a dead man walking from their property to their corporation. The states are perfectly capable to print and coin value based money ending all direct and indirect taxes on its natural born.

The current form of federal, state, county and city municipal corporations are managed on high like syndicated rackets. Their is a Godfather, have no doubt about this. The global mobs apply the worst of both worlds of the private and public corporations. Large uncontrolled private corporations take over through monopoly, oligopoly via lobbying which sanctions sharking out anything that competes with them. The public municipal corporations not only shark out competition, they extort, threaten, harass, jail, imprison, foreclose, confiscate, legislate, "judicate", administrate, regulate, fine, license, permit, zone, shut down and tax to death all the natural born state Citizens who they swore on oath to protect.



This table shows that the vast majority of the colonial "states" did not want the dreaded direct taxes. Why would they, they just fought and died to stop it. Some states still could not learn and still wanted it but with very strict limitations. This was all ignored by the Federalist and the apportioned direct tax was written in probably at the insistence of the central banksters and liewyers all British trained.

Even the so called apportioned direct tax or head tax/poll tax mentioned in the US Constitution is illegitimate because:

- The majority of the delegates and "states" at the time did NOT want it, but it was weaseled worded into the Constitution anyway.
- The then 13 Republics and Commonwealths legislators did NOT vote for the US Constitution nor did the relative few voting eligible men at the time
- Those against a central union of the states were strongly against the Constitution, they were prophetic in hind sight (more debtor class)
- Those for a central union of the states were the more intellectual, merchants, lawyers, large land owners (more creditor class)
- The Federalist fears came true unfortunately
- The Federalist could only successfully pressure 9 of the 13 "states" to go along with the centralization of power the US Constitution
- The US Constitution Art. VII says 9 states shall be sufficient, that is fraudulent.
  - This is the equivalent of holding up an election until you have enough votes dribble in to win over the cut off time of the election.
- The Articles of Confederation required unanimous approval at the time of the conventions not years later.
- In a Constitutional Republic, the charters cannot be binding on the natural born state Citizens who are free and sovereign.
  - The natural born state Citizens are free and sovereign by their birth rights, i.e. unalienable rights
  - These precious rights are given to you by the Laws of Nature and Nature's God ...
    - NOT by the government or their fictional corporations
  - The union of the states, states, counties, cities are charted by oath and honor to protect you and your property
  - They cannot take your property nor regulate it nor tax it, nor charge you usury nor deny you allodial title

He went around to all of the 50 states and dug up the original papers regarding each states vote on the 16th Amendment (federal "income" tax"). He found 13 states did not ratify it, 12 states did ratify, 23 voted yea but violated their own state Constitutions and all of them had miscellaneous errors. When the US Constitution is amended the states are only allowed to vote Yea or Nay, they cannot alter the amendment but many did. US Secretary Know at the time railroaded it through well knowing they never had the necessary 3/4 of the then 48 states or 36. They only had 35 Yeas and all of them were illegitimate because of errors. Bill Benson has been barred from the Federal District Court in Chicago, see his site.

So you may see where I am going here. I believe all of the several states, <u>as in all 50</u>, individual constitutions are NOT framed in a true and honest Constitutional Republic as they were charged to do, <u>before they could be admitted into the union of the states</u>. Based on preliminary findings researching the State of Washington constitutions, I believe all state constitutions are illegitimate. Can you believe this?
